



TERMS AND CONDITIONS

Introduction:

Welcome to Global IT Engineers. These Terms and Conditions outline the rules and regulations for the use of Global IT Engineers' Website, located at www.gi-engi, and all related services, software, and products provided by Global IT Engineers.

1. Definitions:

- 'Company', 'Us', 'We', 'Our' refers to Global IT Engineers.
- 'You', 'Your', 'User', 'Customer' refers to any individual, company, or other legal entity using our services or visiting our website.

2. **Scope:** These terms and conditions apply to all users of our services, including but not limited to our website, consulting services, software, and any other services we offer. Users can terminate their agreement with us by simply discontinuing the use of our services.

7. **Limitation of Liability:** In no event will Global IT Engineers, or its suppliers or licensors, be liable for any indirect, incidental, special, consequential or punitive damages, including without limitation, loss of profits, data, use, goodwill, or other intangible losses, resulting from the use of our services.
